PRIVACY POLICY

Hoakalei Country Club ("Hoakalei") is committed to safeguarding your privacy while visiting our website at www.hoakaleicountryclub.com ("Website"). Our goal is to provide you with an internet experience that delivers the information, resources and services that Hoakalei has to offer and is relevant to your needs. To achieve this goal, part of the operation of the Website includes gathering certain types of information about Website users. We understand that your privacy is important, and this policy describes the types of information we may collect from you or that you may provide when you visit the Website and our practices for collecting, using, maintaining, protecting, and disclosing that information

This policy applies to information we collect:

- · On this Website, as voluntarily provided by you.
- In email, text, and other electronic messages based on a request you have made via this Website.
- When you interact with our advertising on third-party websites and services, if those applications or advertising include links to this policy.

It does not apply to information collected by:

· Any third party, including through any application or content that may link to or be accessible from or on the Website.

Please read this policy carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, your choice is not to use our Website. By accessing or using this Website, you agree to this privacy policy. This policy may change from time to time (see *Changes to Our Privacy Policy*). CHILDREN UNDER THE AGE OF 16

Hoakalei has designed this Website to be used for informational purposes by all ages. However, as with any Website parental consent is encouraged. INFORMATION YOU PROVIDE TO US

The information we collect on or through our Website may include:

- Information that you provide by filling in forms on our Website. For example, this includes information you provide when you request to visit our club, play our course, make a dining reservation, receive additional information, opt to receive notifications about exclusive promotions and special events presented by Hoakalei and its related companies, including its parent company Sankara Hawaii LLC, or request further services. We may also ask you for information in connection with your requested service, and when you report a problem with our Website or enter a contest or promotion sponsored by us.
- Records and copies of your correspondence (including email addresses), if you contact us.
- Your responses to surveys that we might ask you to complete for research purposes.
- Details of transactions you request or carry out through our Website and of the fulfillment of your reservations and orders. You may be required to provide financial information before placing an order through our Website.
- Your search gueries on the Website.

INFORMATION WE COLLECT THROUGH AUTOMATIC DATA COLLECTION TECHNOLOGIES

As you navigate through and interact with our Website, we may use automatic data collection technologies to collect certain information about your equipment, browsing actions, and patterns, including:

- Details of your visits to our Website, including traffic data, location data, logs, and other communication data and the resources that you access and use on the Website.
- Information about your computer and internet connection, including your IP address, operating system, and browser type.

We also may use these technologies to collect information about your online activities over time and across third-party websites or other online services (behavioral tracking).

The information we collect automatically is only statistical data and does not include personal information. It helps us to improve our Website and to deliver a better and more personalized service, including by enabling us to:

- Speed up your searches.

 - Cookies (or browser cookies). A cookie is a small file placed on the hard drive of your computer. You may refuse to accept browser cookies by activating the

DISCLOSURE OF YOUR INFORMATION

- To contractors, service providers, and other third parties we use to support our business, as needed to fulfill the purpose of their business service. Hoakalei does not disclose information to unrelated parties for advertising purposes.
- To a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of Hoakalei's assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information held by Hoakalei about our Website users is among the assets transferred.
- To fulfill the purpose for which you provide it. For example, if you provide an email address or phone number to contact you with when you request a reservation at Reflections Restaurant via the form on our Website, we will transmit the contents of that email and your email address to the Reflections Restaurant staff.
- For any other purpose disclosed by us when you provide the information.
- · With your consent.
- We may also disclose your personal information:
- To comply with any court order, law, or legal process, including to respond to any government or regulatory request.
- To enforce or apply our terms of play time reservation, sale of goods and other services, and other agreements, including for billing and collection purposes.
- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of Hoakalei, our customers, or others, including the unauthorized use of this Website. This includes exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction.
